

ORDINANCE NO. 99 8-27

TOWNSHIP OF A SECOND CLASS
CLEARFIELD COUNTY, PENNSYLVANIA

**AN ORDINANCE PURSUANT TO SECTION 67304 OF THE
SECOND CLASS CODE TITLE 53 P.S. § 57304 - VACATING
A PORTION OF TOWNSHIP ROAD 678 FROM ITS
INTERSECTION WITH TOWNSHIP ROAD 680
CONTINUING IN A SOUTHWESTERLY DIRECTION TO
WHERE IT INTERSECTS THE DECATUR TOWNSHIP LINE.**

The Board of Supervisors of Morris Township, Clearfield County, Pennsylvania enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1.01: WHEREAS the Second Class Township Code, (53 P.S. § 67304) permits township supervisors to enact, ordain, survey, lay out, open widen, straighten, vacate and relay all roads within the township; and

Section 1.02: WHEREAS, in the judgement of the Board of Supervisors, it is a benefit to the Township to vacate a portion of T-678 from its intersection with Township Road 680 continuing in a southwesterly direction to where it intersects the Decatur Township line and an alternate route being readily available, and being taken with the agreement of the adjoining property owners;

Section 1.03: WHEREAS, the Township of Decatur has previously vacated that portion of T-678 that connects with that portion of T-678 located within Morris Township, being vacated hereby;

SECTION II

VACATION

Section 2.01: The Township hereby vacates a section of T-678, as follows:

That portion of Township Road 678 from its intersection of Township Road 680 continuing in a southwesterly direction for a distance of approximately one-tenth (1/10th) of a mile until its point of intersection with the Decatur Township line pursuant to the Second Class Township Code, Title 53 P.S. § 67304;

SECTION III

TAKING

Section 3.01: The Township hereby takes a portion of T-678, as follows:

Being a portion of Township Road 678 from its intersection of Township Road 680 continuing in a southwesterly direction for a distance of approximately one-tenth (1/10th) of a mile until its point of intersection with the Decatur Township line pursuant to the Second Class Township Code, Title 53 P.S. § 67304.

SECTION IV

EFFECTIVE DATE


Section 4.01: This Ordinance shall become effective five (5) days after the date of the enactment.
