

## MORRIS TOWNSHIP BOARD OF SUPERVISORS REGULAR MEETING

July 3, 2024, 5:30 PM

The regular meeting of the Morris Township Supervisors was called to order by Vice Chairman, Fred Little with a salute to the flag.

A roll call of officers showed Fred Little, Patrick White and Patti Moore. Josiah Jones and Rod Beard were not in attendance.

**Executive Session:** None required.

**Minutes:** The Chairman entertained a motion, Emerson Reams motioned, and Fred Little seconded to approve the June 19, 2024, Board of Supervisors meeting minutes. Motion carried with both supervisors voting yes.

**Financial Reports:** The Chairman entertained a motion, Emerson Reams motioned, and Fred Little seconded to approve the financial report. Motion carried with both supervisors voting yes.

Stan Minko questioned the Mandel Property and the status on it. Patrick White stated it is in the court system.
